2017 IRS Optional Standard Mileage Rates

Internal Revenue Service Notice 2016-79 announced the following optional standard mileage rates effective January 1, 2017:

- Business standard mileage rate 53.5 cents per mile (25 cents per mile treated as depreciation)
- ◆ Charitable standard mileage rate (mileage by someone rendering gratuitous services to a charitable organization) 14 cents per mile
- Medicare care standard mileage rate 17 cents per mile
- Moving expense deductible under IRC § 217 standard mileage rate 17 cents per mile

Maximum Amount for "Conventional Loans" Increases for 2017

"Conventional loans" are mortgage loans that meet Fannie Mae and Freddie Mac qualifications. In central Ohio, the maximum mortgage loan amount that meets these qualifications increases from \$417,000 in 2016 to \$424,000 in 2017. In some higher-cost housing areas, the maximum qualifying mortgage loan amount is higher. Mortgage loan amounts above the Fannie Mae/Freddie Mac maximum qualifying loan amount are commonly referred to as "jumbo loans" and carry a higher interest rate.
