### A Reminder if you Own Residential Rental Property in a Populous County

From our involvement in real estate transactions, we have noted that owners of residential rental property in counties with a population greater than 200,000 (i.e., Franklin County) often fail to comply with the requirements of Ohio Rev. Code § 5323.01, which became effective in September 2006 and requires owners of residential rental properties in such counties to file the required informational form with the county auditor and update it when appropriate. Such an owner who resides outside the State of Ohio also must designate an individual who resides in the State of Ohio as the owner's agent for acceptance of service of process.

The necessary form is generally downloaded from the website of the county auditor in the counties where filing is required.

Ohio Rev. Code § 5323.99 authorizes the county auditor to impose a special assessment on the tax bill of not less than \$50 or more than \$150 on the residential rental property where the owner has failed to do a required filing. Such special assessment is appealable to the county board of revision.

# No FSA, HRA, HSA or Archer MSA Reimbursement, Effective January 1, 2011, for Over-the-Counter Medications

Effective January 1, 2011, health flexible spending accounts (FSAs), health reimbursement arrangements (HRAs), health savings accounts (HSAs) and Archer medical savings accounts (Archer MSAs) can no longer reimburse participants for non-prescribed over-the-counter (OTC) medicines other than insulin. If the OTC item is prescribed by an appropriately licensed healthcare provider, FSAs and HRAs can still provide for reimbursement for such OTC items.

Employees with FSAs or HRAs that have allowed for reimbursement of OTC items will need to amend their plan, along with distributing an updated summary plan description or a summary describing the changes to the plan as to OTC items. An employer should review current materials as to HSA contributions as to statements about OTC items and amend the statements as necessary. Please contact us if you need assistance.
