LEGISLATIVE FEE INCREASE NOTICE PER OHIO REV. CODE §\$ 317.32 AND 317.36

Due to the Ohio Legislature's passage of HB 166, effective October 17, 2019, the recording fees for most documents will increase by \$6. The new recording fee will be \$34 for the first two pages and, as it was before, \$8 for each additional page. The \$4 margin fee and standardization guidelines still apply. Half of all recording fees are required to be submitted to the state to credit the Ohio Housing Trust Fund. FRANKLIN COUNTY RAISES CONVEYANCE TAX TO \$3 PER \$1,000 OF SALES PRICE

The week of August 19, 2019, the Franklin County Board of Commissioners voted to increase the real property conveyance fee/tax to \$3 per \$1,000 of sales price, which is a fee/tax paid on every conveyance by deed of a parcel of real property (which is not exempt under one of the statutory exemptions from the fee/tax). This means that on a house sold for \$250,000, the seller (the grantor in the deed) will pay a fee/tax of \$750.

The Commissioners earmarked the proceeds of the increase, estimated at \$6.5 million per year, toward affordable housing development. Over ten years, Franklin County estimates that the \$65 million in fees/tax will help renovate or build about 2,050 units of affordable to low- and moderate-income households.

Delaware, Licking, Madison and Pickaway Counties are already at \$3 per \$1,000 of sales price. Union County is at \$2 per \$1,000. Fairfield County charges \$4 per \$1,000, which is the maximum amount permitted under the state law authorizing the board of commissioners of a county to charge a conveyance fee.
