Business Opportunities in Meat Processing

In the last month, the USDA announced \$1 billion in loan guarantees under the Food Supply Chain Guaranteed Loan Program, and Gov. DeWine and Lt. Gov. Husted announced that 40 Ohio livestock and poultry producers will receive grants totaling \$10 million to help them expand capacity and meet the growing demand for meat processing services. Closest to Delaware Co. in the case of the state grants are S. and S. Gilardi, Inc. in Knox Co. (\$250,000) and Oiler Meat Processing, LLC in Licking Co. (\$161,310).

"Each company will receive a grant of up to \$250,000, with half of the funds disbursed before projects are started and the other half awarded after the companies show that the initial funds were spent on eligible costs. In total, the businesses receiving awards have estimated that the funds will help them create up to 830 jobs," according to a statement from the DeWine/Husted administration. "These grants will not only benefit consumers, but they will also help sustain these businesses and bring new job opportunities to Ohioans," said Lt. Gov. Husted. "In addition to new jobs, this funding will help businesses retain 300 jobs and nearly \$30 million in payroll."

Since March 2020, Americans have learned that low, low prices may often come with fragile supply chains that have little to no resiliency. The Wikipedia listing for Smithfield Foods includes that: "Then known as Shuanghui Group, WH Group purchased Smithfield Foods in 2013 for \$4.72 billion. It was the largest Chinese acquisition of an American company to date. The acquisition of Smithfield's 146,000 acres of land made WH Group, headquartered in Luohe, Henan province, one of the largest overseas owners of American farmland."

In addition, these kids and their families often have beef, pork, lamb, goat, rabbits and poultry for sale separately from the fair.

2022 Federal Estate and Gift Tax Exemption Amount Changes

For 2022, the lifetime federal estate and gift tax exemption is increased to \$12,060,000, and \$24,120,000 for a married couple who elects portability of IRS Form 706 at the first spouse's death.

For 2022, the annual gift tax exemption increases from \$15,000 in 2021 to \$16,000 for gifts to an individual. With this increase, with agreement between the spouses, a married couple can give \$32,000 to an unlimited number of individuals (for example, to each child, each grandchild) without having to file a federal gift tax return and without the amounts of those gifts counting against the lifetime federal estate and gift tax exemption amounts set forth in the prior paragraph.

Debt Collectors Can Now Use Social Media

In November 2021, the federal Consumer Financial Protection Bureau (CFPB) amended its rules to include rules regarding a debt collector's use of social media to collect debts. The rules are rather restrictive on a debt collector's use of social media. A debt collector cannot hide its identity when requesting to be added as a friend or contact and must advise that it is a debt collector. All social media messages from a debt collector to a debtor must be private, cannot be posted public for the debtor's friends, contacts or followers to see, must provide a simple way for the debtor to opt out from receiving future messages from the debt collector and must follow all other CFPB rules applicable to debt collection. Given the requirement that a debt collector's social media messages to debtors must include a simple way for the debtor to opt out of receiving future messages from the debt collector, it could well be that debt collectors will not utilize social media when they have a valid mail address or email address.

It should be pointed out that the CFPB rules pertaining to debt collection do NOT apply to communications by an entity or individual collecting a debt that is owed, and was originally owed, to that entity or individual.
