Code § 5321.051, prohibiting certain persons from occupying residential premises located within 1,000 feet of any school premises, preschool or child daycare center, was added in July 2003 and amended in July 2007, and Ohio Rev. Code § 5321.131, prohibiting restrictions on flag display (of specific types of flags), was added effective March 2017." The missing information is in italics. The version of the Client Bulletin that was mailed with our monthly invoices was correct.
